Seeks capital appreciation. The Fund pursues this objective through investment in equity securities of companies with the potential for above-average growth in earnings.


GROWTH FUND UPDATE

Growth stocks faced increased volatility in Q1 2025 as inflation concerns and tariff discussions created uncertainty in the market. Sectors reliant on global supply chains, specifically technology and consumer discretionary, experienced the most pressure as potential higher costs weighed on profit expectations. While growth stocks began the quarter in a positive fashion, ongoing trade tensions and negative sentiment led to the sell-off in February and March. The Commerce Growth Fund's return of -8.58% outperformed the Russell 1000 Growth Index return of -9.97%.

Stock selection added to the Fund's performance. The Fund's strongest stocks were Spotify Technology SA (0.93%), McKesson Corporation (0.95%), and Rollins, Inc. (0.87%), returning 22.94%, 18.22%, and 16.94%, respectively. The Fund's top detractors were Deckers Outdoor Corporation (0.00%), Hyatt Hotels Corporation Class A (0.82%), and NetApp, Inc. (0.00%), returning -41.56%, -21.88%, and -20.41%, respectively.

The Fund's sector allocation was positive for the Fund's performance. The Fund's 1.48% overweight in the Energy sector, which returned 11.93%, added to performance as it was the best performing sector. The Index had a 0.46% weight in the Energy sector. However, The Fund's 0.40.50% underweight in the Consumer Staples sector, which returned 3.89%, detracted from performance as it was one of the stronger sectors. The Index had a 3.41% weight in the Consumer Staples sector.
