
Seeks capital appreciation and, secondarily, current income. The Fund pursues this objective through investment in equity investments of companies that are selling below fair market value compared to their future potential.

## **VALUE FUND UPDATE**

Value stocks demonstrated relative resilience amid the turbulent market conditions of Q1 2025. As tariff discussions came more into focus, investors increasingly paid attention to companies that source a lot of supplies and/or products from other countries. The overarching concerns regarding inflation and the potential for an economic slowdown due to escalating trade tensions continue to negatively influence the equity markets. The Commerce Value Fund's return of 1.30% trailed the Russell 1000 Value Index return of 2.14%.

Stock selection detracted from the Fund's performance. The Fund's strongest contributors were Amgen Inc (1.89%), Chevron Corporation (1.95%), and Duke Energy Corporation (2.46%), returning 20.51%, 16.77%. and 14.27%, respectively. The Fund's top detractors were Broadcom Inc, (1.67%), Blackstone Inc. (1.81%), and Oracle Corporation (1.54%), returning 27.56%, -18.24%, and -15.88%, respectively.

The Fund's sector allocation hindered performance for the quarter. The Fund's 1.14% underweight in the Industrials sector, which returned -2.88%, added to performance as it was a weaker sector. The Index had a 14.55% weight in the Industrials sector. However, the Fund's 1.19% overweight position in the Information Technology sector hurt performance as it was a weaker sector, losing -5.65% for the quarter. The Index had an 9.19% weight in the Information Technology sector.

- 3. The Lipper Category 2nd Quartile Total Return Ranking represents the lowest performing fund in the second quartile within the respective Lipper investment category.
